Tech, and PhD programmes in three branches namely Computer Science and Engineering, Electronics and Communication Engineering, and Mechatronics Engineering.

The application fee should be remitted through "SBI Collect" link on the online recruitment portal (https://iiitbh.ac.in/rect2022/NT) only. No other mode of fee payment will be accepted.
- (b) The candidates are advised to duly fill the online application form through the recruitment portal. The duly filled printed application form, along with self-attested supporting documents, such as relevant testimonials, certificates, enclosures etc. must be sent by speed/registered post only to **The Registrar Incharge, IIIT Bhagalpur, BCE campus, Sabour, Bhagalpur-813210, Bihar** by **10.10.2022 till 17:00 Hrs,** failing which their candidature will not be considered.
- (c) The envelope containing the application be super-scribed as "Application for the Post of and the Post Code"
- (a) Original documents along with one set of self-attested copies will have to be produced at the time of interview for verification.
- (b) The minimum qualification is the minimum criteria only for deciding the eligibility. This shall not ensure short-listings for selections process.
- (c) Mere fulfilments of minimum qualifications do not ensure call for selection process. The Institute has the right to set higher norms than minimum while shortlisting, taking into account the specific requirements of the posts and shall be binding on respective post applicants.
- (d) All recruitment and pay-fixation shall be done by the competent authority of the Institute on the recommendations of duly constituted Selection Committees. The Decision of the selection committee shall be final.

- (j) Application form without relevant supporting enclosures shall be summarily rejected. No correspondence shall be entertained in this regard.
- (k) The date for determining eligibility of candidates in every respect, i.e., qualifications, experience and age limit etc. shall be considered as on the closing date, i.e., **05**th **October 2022**, the last date of the submission of online application form.
- (l) More than six months of experience in relevant position in any organization will only be considered in total experience.

- (m) The shortlisted candidates for the post of Group-B and Group-C will be required to appear for written test and skill test as applicable for the relevant post. No interview will be conducted for Group-B and Group-C posts.
- (n) The shortlisted candidates for the post of **Group-A** may be required to appear for written test/skill test/presentation. Finally, the successful candidates after written test/skill test/presentation will have to appear for personal interview before the selection committee.
- (o) Candidates who are applying for **Group-A** posts, shall upload letter of recommendations of two eminent persons along with other documents on the recruitment portal.
- (p) No TA/DA will be paid for attending written test/Interview.
- (q) Persons serving in Govt. / Semi Govt. / PSUs / Universities / Educational Institutions should send their applications either **THROUGH PROPER CHANNEL** or should furnish a **NO OBJECTION CERTIFICATE** from the Competent Authority of the parent organization, at the time of interview.
