It is a joint venture of Govt. of India (50%), Govt. of Bihar (35%) and BELTRON (15%). The Institute was established in the year of 2017, and currently functioning with B. Tech, M. Tech, and Ph.D programmes in four branches namely Computer Science and Engineering, Electronics and Communication Engineering, Mechatronics & Automation Engineering, and Mathematics& Computing.
