**1. ABOUT THE INSTITUTE**

Indian Institute of Information Technology Bhagalpur (IIIT Bhagalpur) is one of the 25 IIITs set up by MoE, Govt. of India under the Act of Parliament, IIIT (PPP) Act, 2017, and it is an “Institute of National Importance”. It is a joint venture of Govt. of India (50%), Govt. of Bihar (35%) and BELTRON (15%). The Institute was established in the year of 2017, and currently functioning with B. Tech, M. Tech, and Ph.D programmes in four branches namely Computer Science and Engineering, Electronics and Communication Engineering, Mechatronics & Automation Engineering, and Mathematics & Computing.

#### **5. GENERAL INSTRUCTIONS AND INFORMATION**

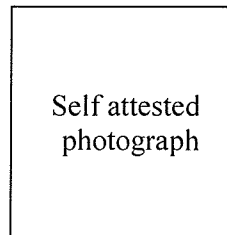

4. Candidates shall indicate two references of eminent persons in the field/profession, with full postal address, email and telephone number, who may be contacted by the Institute for their recommendations.
5. The date for determining eligibility of candidates in every respect, i. e., qualifications, experience and age limit etc. shall be considered as on the date of walk-in-interview.
