2. The interview for non-teaching posts of **NT-1, NT-2, and NT-4** will be held for provisionally eligible candidates only. The date of interview will be intimated later through email, and same will be updated on the website also.
3. The **written test/skill test** will be held for non-teaching posts of **NT-3, NT-5, NT-6, NT-7, NT-8, and NT-9** for provisional eligible candidates only. Therefore, the candidates are instructed to go through the syllabus and instructions for written test/skill test.
4. The shortlisted candidates based on the performance in the written test will only be eligible for interview for **Group-A** posts (NT-3, NT-5, and NT-6). The date of interview will be intimated later through email, and same will be updated on the website also.
5. For **Group-B** (NT-7) and **Group-C** (NT-8, and NT-9) posts, interview will not be held. Final merit list of these posts will be prepared based on the performance in the written test.
