**Terms and Conditions:**

1. A Demand Draft of **Rs. 1,00,000** has to be submitted on the name of "**IIT Bhagalpur**", payable at "**Bhagalpur**". The application would not be considered if a bidder submits his application without said DD.
2. Auction would be done for **one and/ or two years** for only those mango/other tresses which is situated under the demarcated land of IIT Bhagalpur Campus.
3. Auction would be done for only those mango/others tresses which is situated under demarcated land of IIT Bhagalpur Campus.

4. Auction would be done for only those mango/others tresses which is situated under the demarcated land of IIIT Bhaganpur Campus. All the bidders are invited to visit the campus and access the trees situated in the demarcated land of IIIT Bhagalpur Campus before submission of bid application. Bidder may quote either for 01 year or 1<sup>st</sup> year & 2<sup>nd</sup> year combined.
5. The work order is valid till the date; mango/other fruits are removed from the campus (i.e. Aug-July).
6. The bidders have to submit their bid in a closed and sealed envelope along with a DD of Rs. 1,00,000 as mentioned in Sl. No. 1 on or before of 21<sup>st</sup> July 2022, 02:00 PM at office of IIIT Bhagalpur.
7. All the bids will be opened on same day, 04:00 PM in the presence of committee.
8. The bid would be awarded to that bidder who have quoted the highest price and submit the quoted amount within a week from the date of award of the bid. The DD amount of Rs. 1,00,000 would be kept as a caution money and returned to him once all the fruits are removed from the trees. If the successful bidder fails to submit the quoted amount within a week, the caution money of Rs. 1,00,000 would be ceased.
9. The submitted DD would be returned to all the unsuccessful bidder except one who has been awarded the bid.
10. The competent authority would be authorized to hold or cancel the auction process anytime without providing any information.
11. Mode of the payment for highest quoted bidder will be as follows:
  - (a) **Case-I (for one-year quoted)**  
The successful bidder will be required to complete 100% payment within one week, after that the work order will be issued to successful bidder.
  - (b) **Case-II (for two-year quote) (1<sup>st</sup> year & 2<sup>nd</sup> year combined)**  
The successful bidder will be required to pay 70% of the quoted amount for two years within one week, then the work order will be issued to the bidder, and the remaining amount must be paid to 31<sup>st</sup> July, 2023. Otherwise deposited amount along with caution money will be ceased and contract will be cancelled for 2<sup>nd</sup> years.
12. If the committee feels, the successful bidder will be invited for further negotiation.
13. Legal disputes, if any, with IIIT Bhagalpur, will be restricted within the jurisdiction of Hon'ble High Court of Bihar, Patna only
