3. Tendering would be done for only those mango/other tresses which is situated under the demarcated land of IIIT Bhagalpur Campus.
4. All the bidders are invited to visit the campus and access the trees situated in the demarcated land of IIIT Bhagalpur Campus before submission of bid application.
