GENERAL INSTRUCTIONS AND INFORMATION:

- 2. Last date of submission of online application is 26/02/2024 by 5:00 PM.
- 3. Last date of receipt of hard copy of duly filled application form, along with all supporting documents, duly self-attested is **05/03/2024; 5:00 PM.**
- 4. Each application must be accompanied by non-refundable Application Fee of ₹ 1,500/-(Rupees Fifteen Hundred Only) for UR, OBC-NCL; ₹ 750 (Rupees Seven Hundred only) for SC/ST/EWS. PwD candidates are exempted from Application Fee. The application fee should be remitted through "SBI Collect" link on the online recruitment portal (https://iiitbh.ac.in/rect) only. No other mode of fee payment will be accepted.
- 5. This is an advertisement governed by the 4-tier Flexible Faculty Recruitment Rules as adopted by IIIT Bhagalpur. Relevant instructions issued from the Ministry of Education till the date of interview will be applicable on this advertisement.

- 6. Number of vacancies in all or any of the categories (including reserved vacancies) may be increased or decreased without any notice. The number of seats across the department may increase or decrease.
- 7. For the academic departments which are not having any vacancies, movement in higher academic level or cadre may be carried out as per specified selection process but will be restricted only to serving faculty members of the respective department of the Institute as per Note 1(5) of recruitment rule as adopted by IIIT Bhagalpur.
- 8. Since all the posts are to be filled-in by open advertisement only, internal candidates aspiring for higher posts/Pay Levels/Higher cadre may also apply through online portal only subject to fulfilling eligibility criteria.
- 9. The Institute will not be responsible under any circumstances for any sort of postal delay.
- 10. The Institute shall retain the applicant data for non-shortlisted candidates only for three months after the completion of recruitment process.
- 11. Candidates who wish to apply for more than one post should apply separately for each post in the prescribed manner and separate online application form along with Application Fees should be submitted.
- 12. Application form without relevant supporting enclosures shall be summarily rejected. No correspondence shall be entertained in this regard.
- 13. Candidates shall indicate two references of eminent persons in the field/profession, with full postal address, email and telephone number, who may be contacted by the Institute for their recommendations.
- 14. The Institute has the right to set higher norms than minimum and areas of specialization while short-listing. Norms may not be uniform across the departments/ posts of the Institute and shall be binding on all the applicants. The decision of the Institute related to all matters pertaining to the recruitment shall be final and binding on the applicants.
- 15. The shortlisting criteria will be decided by the Institute to restrict the number of candidates to be called for Test / Presentation/Interview.
- **16.** The date for determining eligibility of candidates in every respect, i.e., qualifications, experience and age limit etc. shall be considered as on the closing date, i.e., the last date of the **submission of online application form.**
- 17. More than six months of experience in relevant regular position in any organization will only be considered in total experience.
- 18. The shortlisted candidates may be required to appear for test/presentation/seminar, in addition to facing the Selection Committee. No TA/DA will be paid for attending test/Interview.
- 19. Persons serving in Govt./ Semi Govt./PSUs/Universities/Educational Institutions should send their applications either through PROPER CHANNEL or should furnish a NO OBJECTION CERTIFICATE from the competent authority of the organization serving, at the time of interview otherwise they may not be allowed for interview. However, they can submit the advance copy of the application form.
- 20. Valid Caste/Category certificates in prescribed format [Annexure A (for SC/ST) and Annexure B (for OBC-NCL)] are required to be submitted along with application form. No other certificate will be accepted as a sufficient proof. The OBC-NCL certificate must be issued by the competent authority on or after 1st April, 2023.
- 21. The EWS candidates are required to submit the certificate as per the **Annexure C** issued by the competent authority on or after 1st April, 2023.

- 22. Reservation for EWS /SC/ST/OBC-NCL and PwD candidates will be strictly as per the Central Govt. Rules.
- 23. The differently abled persons (PwD) shall be required to submit along with application form the Disability/Medical Certificate in the prescribed form issued by the competent medical authorities for the purpose of employment as per Government of India. Persons suffering from 40% of the disability or more shall only be eligible for the benefit of reservation under this category. [Annexure D1/D2/D3 as applicable].
- 24. Original documents along with one set of self-attested copies will have to be produced at the time of interview for verification.
- 25. The applicants are advised/required to visit the Institute website www.iiitbh.ac.in regularly. The list of candidates short listed for further participation in the selection process such as presentation/interview etc. will be displayed on the Institute website. No separate communication or intimation in this regard shall be made by the Institute.
- 26. Legal disputes, if any, with IIIT Bhagalpur will be restricted within the jurisdiction of Bhagalpur only.
- 27. Candidate having degree in inter disciplinary branches/areas and eligible for teaching the interdisciplinary subject may also apply.
- 28. Self-attested copies of the following Documents/certificates are required to be attached with printout of the Online Application Form, failing which the application would be summarily rejected.
 - i. Age proof: Matriculation/10th Standard or equivalent certificate indicating date of birth, or mark sheet of Matriculation/10th Standard or equivalent issued by Central/State Board indicating date of birth will be considered in support of their claim of age. Where date of birth is not available in certificate/mark sheet, issued by concerned Educational Boards, School leaving certificate indicating date of birth will be considered.
 - ii. Higher Secondary / Class XII (or equivalent) board marks sheet.
 - iii. **Preceding degrees**: Degree certificate of UG and PG along with mark sheets pertaining to all the academic years as proof of educational qualification claimed. In the absence of a particular Degree certificate, mark sheets of the Degree program will be accepted.
 - iv. **Essential qualification**: Ph.D. Degree or Notification of Ph.D. award issued by the authorized signatory (not the Mentor/Supervisor/Head of the Department).
 - v. NOC and Experience Certificate(s) from the Head(s) of Organization(s)/ Authorised Signatory for the entire experience claimed, clearly mentioning the duration of employment (date, month & year) indicating the basic pay and consolidated pay. The certificate(s) should also mention the nature of duties performed/experience obtained in the post(s) with duration(s).
 - vi. Disability certificate in prescribed proforma [Annexure D1/D2/D3 as applicable] only issued by the competent authority to the Person with Disability for being eligible for appointment to the post on the basis of prescribed standards of Medical Fitness.
 - vii. Duly Signed Credit point summary sheets (Annexure-I, Annexure-IIA, Annexure-IIB and Annexure-III) are to be filled by the applicant for the post applied and to be submitted along with Application form.
